On a final note, we have been in contact with Jeff McKeil of FPSE to invite him to the College once again to provide training sessions for our members. Last year, he gave talks on Collegial Authority as well as Governance. We hope to have Jeff provide these sessions again for new members and those who may have missed them last year. There may even be some additional sessions. We are planning for these to take place in October or November. I'll let everyone know as soon as the dates are finalized.

Second Vice President's Report

The tempestuous political climate in the province right now, though, adds an unpredictable dimension to our planning. We appreciate the ongoing support of our membership and look forward to making a full report on progress at the Fall General Meeting.
