T Berg explained that the 2020 – 2021 school year will be the 20<sup>th</sup> anniversary of the NTEN program. In consultation with industry and PAC, the department noted that the current program title did not clearly identify the focus of the program. The new title, Infrastructure and Computing Technology Diploma, better reflects the content and reflects future trends within the industry. The course codes will change to ICT to accommodate the program name change. There is no change to the content.

### e. Course revision: DSCI 100 Introduction to Data Science 1

That Education Council approves the course revision: DSCI 100 Introduction to Data Science 1 as recommended by the CPRC – STH:

- J Hobart gave an overview of the changes to the program. There have been two intakes into the program this past year. In the second intake, the department noticed a lot of business students taking DSCI courses as electives. However, as the courses are part of a Post Baccalaureate Diploma program, these students found the level of sophistication within the courses not indicative of 100 level courses. This is not fair to students. The major revision is to renumber the courses to reflect the level of difficulty, as well as some housekeeping revisions. The course names are changing to be more descriptive and properly reflect the content of the courses.
- DSCI 100 will become DSCI 300, with a new title to better reflect content. Students will not be able to take DSCI 300 for credit if they have already taken DSCI 100.
- A member noticed a typo in the prerequisites.

## k. New program: Concentration in Data Science and Statistics

Motion: D Marques/ M Somerville

That Education Council approves the new program: Concentration in Data Science and Statistics as recommended by the CPRC – STH:

- J Hobart explained that the new concentration follows the flow of the concentrations in computer science and communications. The DSCI courses have been packaged in a way that computer science students and business students can take the courses as electives and receive additional distinction on their transcripts.
- Students must take both introductory DSCI courses. They also need a course on linear algebra, introductory statistics, and two additional courses from the list including the other DSCI courses or 300 and 400 level statistics courses.
- A member noticed a typo in the program outline.
- A member questioned the admission requirements and how students could receive admission into a concentration. J Hobart explained that the program was designed within the confines of the current Education Council forms. The concentration follows the example of the concentration in communications.
- A member questioned if the department would consider other equivalent STAT courses, like PSYC 270. J Hobart advised that he would have to look at this at a case by case basis.

The inclusion of this language was just to point out that the opportunity to present at seminars is available for appointees.
- A member questioned why the two policies had been combines. A Hay advised that it is simpler to have one policy.

# **Program revision: Therapist Assistant Diploma**

- Members were sent documents related to emergency temporary changes to the Therapist Assistant Diploma. Given the pandemic, students are unable to complete their practicum hours.
- Y Moritz noted students were having difficulty finding clinical placements. The accrediting body has been meeting with schools to discuss the issue and have agreed to a reduction of practicum hours over the two year program. This change is temporary.
- A member questioned if there are other programs whose practicums have been delayed and if any changes have been made for those students. Y Moritz noted it depends on the accrediting body as it is their decision hours cannot be reduced without their approval. She added that most health students are still able to attend their practicums as they are considered an essential service. While there have been changes in other programs, hours have not been reduced.
- A member questioned how this would be noted in the calendar. Y Moritz advised that she would work with B Burge to work this out.
