5.1 Curriculum recommended by the CPRC - AFP

a. Course revision: ARTS 498 Field Placement

Motion: J Garrett/J Ragsdale

That Education Council approves the course revision: ARTS 498 Field Placement as recommended by the CPRC - AFP:

- O Sullivan provided an overview of the changes to the proposal. Changes to:

- Course title from Practicum or Field Placement to Field Placement
- Calendar description wording clarification of contact hours
- Prerequisite section
- J Garrett sought clarification on the use of the phrase "taken all selected courses" in the prerequisite section. O Sullivan was asked to clarify why taken was utilized instead of a minimum grade.
- O Sullivan clarified that students are required to obtain 55% and agreed to modify the wording.
- A Hay then sought clarification on what previously existed and asked whether this was now being changed to 55%.
- O Sullivan explained and reiterated that a minimum of 55% was required for each course.
- D Mehus asked whether there were courses that were counted as pass/fail that did not count towards a student's GPA.
- Members clarified that this was the case.
- O Sullivan explained that the language edit in the calendar description to the contact hours would provide students with greater flexibility to take the course.

b. Program revision: English for Academic Purposes

Motion: M Somerville/B Hall

- V Albrecht explained that the revision to the proposal was intended to change/amend the current levels in the program.
- Currently there are three (3) levels to the program and at the level 3, students are permitted to take two (2) academic courses while working on their English for Academic Purposes (EAP) certificate.
- Following department assessments, it is recommended that the number be changed and students permitted to take one (1) academic course. This will be more manageable for students and will aid their success.
- W Gillett concurred that the change would aid student success and was a good change.
- J Garrett sought clarification on the comment in Kuali and the additional consultation that was required.
- D Marques confirmed that the consultation was completed.

a. Course revision: PHYS 240

Introduction to Biophysics

Motion: D Mehus/A Hav

That Education Council approves the course revision: PHYS 240 Introduction to Biophysics as recommended by the CPRC - ST:

- T Bridges provided an overview of the proposal revision, noting the following:
 - Changes to prerequisite section removal of second year standing and simplifying language for the biology requirement.
 - Change to calendar description removal of reference to BIOL 240 that is no longer offered.
- A Hay sought clarification on whether BIOL 240 was still listed as an active course in the calendar
- B Burge clarified that this was not the case.

b. Program revision: Health Science Option: Kinesiology Diploma Motion: J Ragsdale/B Hall

That Education Council approves the program revision: Health Science Option: Kinesiology Diploma as recommended by the CPRC - ST:

- L Blais provided an overview of the revision, noting that the Kinesiology program was previously revised. However, with changes to UBCO's curriculum, OC students will be required to complete Pathophysiology for Health Sciences to obtain third year standing.
- The proposal is to add BIOL 260 (Pathophysiology for Health Sciences) as an elective for students.
- J Garrett sought clarification regarding the comment in Kuali and making students aware of the BIOL 260 requirement.
- L Blais explained that a mechanism was in place to ensure that students are made aware of the new requirement and noted that this was outlined at the CPRC meeting.
- D Mehus sought clarification on when BIOL 260 would be offered and whether the addition to the course load would be manageable/feasible for students.
- L Blais explained that the course would be offered in the Winter semester 2024 and this semester would be a lighter one as more electives would be offered to students.
- L Blais added that the pathophysiology course would be beneficial for all students.

- J Hobart provided an overview of the Post-Diploma Certificate in Data Science, the Post-Baccalaureate Diploma in Data Analytics and Economics and the two (2) new courses being proposed.
- The post-baccalaureate is similar to the other post-baccalaureate programs with an application in Economics that focuses on a different interest group.
- The post baccalaureate is a two-year program. As a result of the economic and time series data, STAT 443 Time Series Analysis and Forecasting has been created.
- DSCI 491 Data Science Research Project, which is research based, has also been added to the program.
- J Hobart explained that Post Diploma Certificate in Data Science, which is a one-year program has also been created.
- J Hobart noted that there is limited domestic interest for some programs and the program was created for students who may not want to take a two-year program.
- W Gillett sought clarification on the wording in the admissions requirements section
 which stated, "a post-secondary basic calculus course and some basic programming
 skills is highly recommended" and asked whether this would be a concern for
 persons with degrees in other areas.
- J Hobart explained that although it would be beneficial, it was not required as the program would provide students with the training needed.
- D Mehus asked whether it would be worthwhile to have an assessment for calculus for students entering the post-diploma program.
- J Hobart explained that this would not be needed as the relevant details are outlined in the course description for students who enter at different levels.
- J Garrett sought clarification regarding the post diploma certificate and whether students could have a credential from any area.
- J Hobart clarified that this was the case, but it would be a good ladder for anyone with a degree in business.
- J Garrett noted that a clear statement should be placed in the calendar description outlining that the MATH 314 and STAT 230 courses are included in the required 24 credits.
- J Hobart noted that this could be outlined.
- B Burge informed the committee that the information relating to the courses was referenced in the outline.

- W Gillett asked whether the total credits to obtain the post diploma certificate would move from 24 to 30 if students did not have STAT 230 and MATH 314 courses.
- J Hobart confirmed that this was correct.
- W Gillett sought confirmation on whether these were essentially prerequisites/corequisites.
- J Hobart responded in the affirmative.
- N Fassina sought clarification on the market demand and the intended target learner for the programs.
- J Hobart explained that for the post diploma this would be domestic and for the post-baccalaureate this would be international.
- W Gillett reiterated that the post-baccalaureate programs have more interest for international students.
- J Hobart noted that it was difficult to outline how many students the post diploma program would attract.

c. New course: DSCI 491 Data Science Research Project

- D Mehus sought clarification on the rationale for the information outlined.
- J Hobart provided an explanation of same.
- N Fassina sought clarification on the residency limitations.
- B Burge confirmed that this was 50%.
- Following a discussion by members, B Burge indicated that an environmental scan would be done.

5.3 Curriculum recommended by the CPRC - BUS

- B Ridgeley provided an overview of the program noting that the proposal was for a two-year Paralegal Diploma program.
- Program is offered in a vocational setting 30 hrs a week.
- Worked with stakeholders to build the program as this was limited in the Okanagan.
- B Ridgeley thanked J Garrett and B Penfound for their assistance with the review of the proposals.
- D Mehus sought clarification on the prerequisites and asked whether the prerequisites were all 200 level courses and if the 100 level courses were part of another certification.
- B Ridgeley responded in the affirmative and noted that the courses were built into the program.
- Courses are blocked registered and the current program would be done face-to-face in the initial offering.
- D Mehus asked whether the paralegal certification was offered privately.
- B Ridgeley explained that the program was not offered in the Okanagan.
- B Hall asked whether a student could gain work experience as a Legal Secretary/Administrative Assistant and then return to do the paralegal diploma.
- B Ridgeley clarified that this could be done, once the student completed their first year at OC. If students completed their education at another institution, the courses would need to be assessed.
- M Somerville asked whether there was a timeline for entry into year two/starting the Paralegal Diploma.
- B Ridgeley explained that this should be within the last five (5) years because of legal changes.
- T Becker concurred with B Ridgeley and added that technological advancements would also have taken place.
- Additionally, OC is working with the relevant stakeholders to be added to the list of recognized public institution providers of paralegal education.

- T Becker explained that would not be done immediately and the first set of students would need to complete the program.
- T Walters sought clarification on whether other institutions have unpaid practicums.
- T Becker confirmed that this was the case.
- T Walters noted that four (4) months seemed liked a long time for an unpaid practicum.
- T Becker and B Ridgeley provided an explanation for the structure of the practicum and explained that it was based on stipulations outlined.
- D Mehus asked whether the practicum was a pass/fail course or based on a percentage.
- B Ridgeley explained that that the course was not a pass/fail and was percentage based 60% of the grade will be based on prior courses and 40% will be employer evaluation
- Several members outlined that the information in Kuali indicated a pass/fail course.
- B Ridgeley noted that the information should reflect a percentage and not pass/fail.
- B Burge indicated that checks would be conducted on the information in Kuali.
- Following discussions and recommendations from the members to retain the pass/fail, B Ridgeley noted that if the checks determined that the practicum would

have to stay as a pass/fail, then the department would simply establish a rubric for the grading.

- A member of the committee outlined that the 2nd page of the LSEC 223 course outline would need to be edited as it stated that the practicum was a paid one.
- B Ridgeley indicated that this would be edited to reflect that the practicum is unpaid.
- B Hall sought clarification on how instructors determined the benefit of the practicum payments if these were arbitrary.
- B Ridgeley clarified that the students are responsible for finding their own job placement.
